# sentenced in molestations

A Newtown Square man yesterday was sentenced to 16½ to 37 years in prison for sexually molesting mine Delaware County boys.

Paul David Memmo, 31, of the 300 block of First Avenue, showed no emotion as County Judge Charles C. Keeler handed down the sentence after hearing from parents of several of the victims.

"He didn't just molest bodies, he molested souls," said the mother of a 12-year-old Ridley Township victim.

"He has taken their whole lives,"
the mother said "We can never
bring back their innocence or
youth."

In explaining his sentence, Keeler said, "My paramount concern is the protection of society."

Defense attorney Francis A. Holloran Jr. had urged that Memmo be hospitalized for long-term psychiatric treatment.

"This is not a monster, he is a sick young man," Holloran, said. "Paul. Memmo is not a lost cause — he can be treated."

In May, Memmo pleaded guilty-to-20 sex offenses, including involuntary deviant sexual intercourse, sexual abuse of children and indecent assault.

In pleading guilty, Memmo acknowledged that he had molested the nine boys, ages 9 to 14, between-January 1986 and May 1990. The victims were boys he befriended. In many cases, Memmo falsely told the boys parents that he was affiliated with the Big Brother organization.

According Deputy District Attorney A Sheldon Kovach, most victims. came from broken homes.

"Memmo gained the trust of nearly: all of their parents," Kovach said. "He was a surrogate parent — a lot of them felt as betrayed as the kids."

In each case Memmo would initially take the boys out to participate in legitimate recreational activities.

However, as he gained their confidence, he brought them to his home and showed them pornographic movies. For money or favors: the boys were encouraged to participate in sex acts.

"Memmo used suggestion, encouragement and seduction to coerce the boys into sexual acts," Kovach said:

# Delco man, 30, is charged in sex abuse of 8 more boys

After a preliminary hearing in Crum Lynne District Court on Wednesday on the alleged sexual assault of two boys, Paul David Memmo, 30, of the 300 block of First Avenue, Newtown Square, was charged with sexually abusing eight more boys.

A preliminary hearing is scheduled for next Wednesday on the additional charges that include involuntary deviate sexual intercourse, sexual abuse of children, indecent assault and corruption of minors. Two of the boys were abused sexually, according to court records, and the others were involved in viewing or posing for obscene material. The incidents allegedly occurred in Memmo's former apartments in Upper Darby, Ridley Park and Media from 1986 to 1988.

Memmo was ordered to stand trial in the assaults of the two boys and was returned to Delaware County Prison, where he is being held on \$400,000 bail.

I received a telephone call on December 3, 1990, from Lt. Bucci with the District Attorney General's office in Delaware County, PA, (telephone # 215-891-4700) trying to find out if a Paul Memmo was registered or working with the BSA in this area. Lt. Bucci told me that Mr. Memmo had been convicted of molesting kids in 1983 in the Valley Forge Council. He lived around the Newtown Square (PA) area, and they thought he was associated with a family in or around the Colony Blvd. area of Wilmington and the University of Delaware.

We ran Paul Memmo's name through the computer and he is not registered in the Del-Mar-Va Council. At present we are trying to find out if he has offered to "help" any of our units in the area.


This is to inform you that the Newtown Township Police Department has arrested Paul Memmo of 304 First Avenue, Newtown Square on the following charges: Corruption of the Morals of Minors, Indecent Assault, Indecent Exposure, Criminal Solicitation and Having Obscene and Sexual Material.

The arrest took place due to a Complaint from Scout Troop 238 in Broomall, Pa. He is charged on 3 counts of each of the above. He was arrested June 8, 1983 and was arraigned. He is now incarcerated in the Delaware County Prison in lieu of \$52,500 bail for a Hearing on June 16, 1983 before District Justice Malone. We have taken statements from Mr. Mammeo to indicate his quilt.


