Dear Paul:

I have finally gotten around to your letter of December 20, 1983 and apologize for not answering sooner.

Mr. Purcell is not being prosecuted by the parents.

Mr. Purcell is caucasian and we have been unable to secure his Social Security Number.

He did not resign in writing. He was confronted by the President of the School Board of the Catholic High School where he teaches and asked to resign his teaching position. The Scoutmaster of the troop, his brother, asked him to resign as Assistant Scoutmaster when he heard of the incident. The troop committee was told of the incident, it backed the Scoutmaster in what he did.

I talked with Mr. Purcell on the phone after talking with the President of the School Board and the Scoutmaster and told him that he was no longer registered with the Boy Scouts of America and could not be registered at any time in the future. His reply to me was that he understood.

We found out about the incident from President of the Kelly School Board where Andy Purcell was teaching and the two boys attended this Catholic School. Mr. told us that Andy Purcell resigned after being confronted and he admitted that it did take place.

We also talked to Jeff Purcell, his brother, who is Scoutmaster of troop 85 and he also confirmed that the incident took place and that he did not find out about it until being told by people related to the school.
