Earlier this year we had correspondence concerning two individuals for whom you sent confidential record sheets. These were Joseph Zottoli and Gary L. Strain.

At that time we indicated that we would like more information which would substantiate our refusal of registration wherever those individuals might move. We really need some documentation such as complete statements indicating the reasons for refusal of registration, newspaper clippings or letters from individuals. We would also like know if these individuals have been convicted of their charges and what sentencing took place. Copy of court records if available would be most helpful.

If we do not receive more information than the confidential record sheet, it will be most difficult to maintain them on file and refuse registration in other localities.
