

We were recently made aware of a situation which has been substantiated by written statement. You have been identified as initiating and encouraging a minor to participate in an unlawful and immoral act.

Further, District Executive Richard Searle has discussed the allegations with you on two occasions and on neither occasion have you denied the act.

The Boy Scouts of America asks that you discontinue your involvement in all Scout related activities and strongly suggests you make no contact with any adult or youth in Cub Scout Pack 368 at La Mesa Elementary School in Albuquerque.

If you feel you have been falsely accused, you may contest within the next ten days by contacting me, Dean Lollar, Scout executive, Great Southwest Council, Boy Scouts of America.
