

Dear Paul,

A former Scouter of ours is being convicted of child molestation. The former Scoutmaster's name is James David Paff. His address is 8202 Stuart & Gray, Downey, California. His birthday is August 29, 1936. He has been serving as Scoutmaster of Troop 423 of District 02 in our council. His trial just concluded in Ontario, California. He was found guilty of sexual molestation of a minor. The case number is 84-49-25. Our information was received from Detective Elsassier of the Downey Police Department. The charge and verdict had to do with the long term relationship between the Scoutmaster and a boy who was twelve years old when the relationship began and is now 15 years old.

Troop 423 did not recharter in 1984, but was a long time Troop.
