Thank you for the detailed information concerning the above Scouter. We have reviewed this case with our Attorney and have now placed this man permanently on the Confidential File.







On Thursday, August 30 I received a phone call from who is Scoutmaster of Troop 232. He stated over the phone that one of his Scout leaders has been implicated in sexual activities with one of the Scouts in the troop.

I had a follow up meeting with Mr. on Friday, August 31. He stated that the assistant scoutmaster under suspicion is Albert A. Polinski. The Scout who reported the incident was

Mr. stated that the following action has been taken:

- 1. He has met with the family to provide counseling and assurance.
- 2. The family had reported the incident to the Salinas Police Department, who are investigating.
- 3. Mr. Polinski had been removed from any leadership capacity in Troop 232 by committee action.

The Monterey Bay Area Council will not accept Mr. Polinski's registration in any capacity pending a report from the Salinas Police Department and with a investigation of our own.
