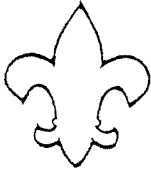

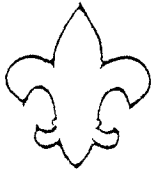

## Man is charged with sodomy

By The Star's staff

**A** 54-year-old Excelsior Springs man has been charged with sodomy involving two children.

William O. Lewis, 109 Temple St., was charged Tuesday by Clay County authorities with two felony counts of forcible sodomy involving a 3-year-old girl and a 1 year old boy, authorities said. He was being held today in the Clay County Jail in lieu of \$10,000 bond. A preliminary hearing has been set Jan. 25, Clay County officials said.

11. Bill Harman of the Excelsior Springs Police Department said the man is a longtime member of the community. Earl Shumate, a unit commissioner for Boy Scout Troop 309 and Cub Scout Pack 309, said Mr. Lewis is a Cub Scout pack leader in Excelsior Springs. The children involved in the sodomy charges were not part of the scouting group.
