

I understand that this information may not mean a whole lot on the surface, but I hope it can prove that I am trying to better myself and become a better person.

I attained Eagle Scout while in the Scouting program and now, looking back on the entire situation, I am ashamed of what I did and feel that I was given a second chance at life in general. As far as my scouting expereience itself, I don't think anyone will argue that I was far above average in leadership ability as well as akill in craftsmanship. I believe that Bob Faris can attest to that

Please don't misinterpret this request as my way to get back into the program easily. I realize how wrong the act was that I allegedly committed was. I am willing to enter the program under any conditions that the National Council would deem necessary. I wouldn't expect it to be any other way.

My aspirations for the future include many things. Educationally speaking. I expect to complete my degree in Elementary Education and plan to teach 7th or 8th grade math. I then plan to enter graduate school to pursue a Masters degree in Administrative Education. After that, I expect to go back to graduate school and earn a Doctorate in Child Psychology. Career-wise, I plan to begin teaching once out of school, then I plan to move on to an
