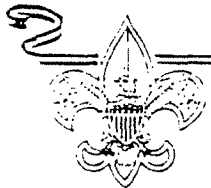

Dear Paul:

We appreciate your patience and follow through on the above situation. We have been waiting for the final court action and decision before submitting the enclosed report.

We are aware of the seriousness of the problem Eric Hacking committed, a first degree felony in the state of Utah in sex molestation. In the court proceedings and under the circumstances present, the Judge dismissed the mandatory prison sentence under the following five circumstances:

1. That he would accept being on probation and parole for three years.
2. That he would be available to the Court during that period of time.
3. That he will violate no laws during that time.
4. That he will be enrolled immediately in the sex offenders program at Utah State Hospital and complete the program.
5. That his case will be reviewed in six months.

Under the circumstances, when Eric completes the sex offenders program, would he still be prohibited from being involved in Scouting? We need your input and judgment.
