Man arraigned for child rapes

LYNN— Robert Breen, 43, 41 Lovers Leap Ave., pleaded innocent Wednesdayto charges that he raped three boys during the past two years.

Superior Court Judge James McDaniel Jr. set bail at \$50,000 and Breen was remanded to Salem Jail for lack of surety. Assistant District Attorney

Assistant District Attorney Michael Lauranzano had asked that surety be set at \$35,000, or \$3,500 cash bail. Judge McDaniel set the higher figure after Lauranzano said Breen was considered by psychiatrists to be a danger to him/elf and others.

A pre-trial conference is set for Sept. 19.
