The Scout then asked to leave to go to the restroom and ran directly to our Camp Office. No violence happened, and Mr. Barnhart was escorted out of camp immediately. At this date he is sekking psychological help. Mr. Barnhart is married and has three (3) children. He was serving as a provisional Scoutmaster on July 18th. The council president, lawyer and physician were notified. The Scout's parents were notified and came to camp on the evening of the incident. The Scout remained in camp and did not seem to show any signs of having troubles because of the incident. I feel that Mr. Barnhart's membership should be rescinded, and he should never be able to register in the Boy Scouts of America again.


