Police arrest man

A Marion man was arrested on six counts of child molesting Monday, Indiana State Police Det. John Starkey said.

Lowell D. Warren, 50, 5 Leffler Court, Marion, was being held Monday night in Grant County Jail in lieu of \$50,000 bond.

Starkey said state police received a call Dec. 19 from a family in Jay County who said their two daughters had been molested by Warren. The incidents started sometime in 1979 and continued until the summer 1984, Starkey said.

The incidents happened in Grant County. The two girls were five or six years old when the incidents started.

Starkey said the incidents happened at the Warren house in Matthews. Warren had recently moved to Marion, Starkey said.

Starkey said Warren had been employed for about 11 years as a police officer at the Veteran's Administration Hospital, Marion.

Warren was arrested at 2 p.m. Monday at the office of his lawyer, Mel Corn, in Marion. He was then taken to Grant County Jail.

Man receives 10-year sentence for molesting

An Upland man was sentenced Thursday in Grant Superior Court 2 to 10 years in prison for child molesting.

Lowell Warren, 51, 10015 E. 1000S, Upland, received 10 years on each of the two charges, but the sentences will be served at the same time.

Warren, who was arrested March 4, pleaded guilty to the charges, involving two girls, July 16.
