Mr. Swentik invited us into his home and I told him I had a letter to hand deliver to him. Mr. Swentik read the letter and Mr. Stoyer thanked him for his past service to the troop.

We took our leave and Mr. Swentik asked me if I knew the final disposition, and I said no.

After leaving Swentik's I checked with Peter W. Hansen, Assistant County Attorney. He informed me that the Swentik's received a "Deferred Judgement" -- two years probation -- must participate in a counseling program -- at the end of two years with no problems the record will be erased.
