

SUBJECT: DAVID SHERRARD

DATE: TUESDAY AUGUST 13, 1985

THE ABOVE-MENTIONED MAN REGISTERED AS ASSISTANT SCOUTMASTER WITH TROOP 314, SPONSORED BY MT. ZION BAPTIST CHURCH, 1516 EAST 30TH STREET, LORAIN, OHIO, HAS CAUSED THE FIRELANDS AREA COUNCIL TO ASK SAME TO RESIGN OR HAVE ACCEPTED DISASSOCIATION AS A REGISTERED SCOUTER IN THE FIRELANDS AREA COUNCIL, BOY SCOUTS OF AMERICA.

TWO LETTERS WERE PREPARED, BOTH CHECKED BY OUR LEGAL COUNSEL, AND BOTH APPROVED. VOLUNTARY RESIGNATION LETTER WAS ALSO READ TO PAUL ERNST; AND HE APPROVED ATTACHED LETTER.

ON TUESDAY EVENING AUGUST 13, DONALD WILSON, DISTRICT COMMISSIONER, AND MYSELF STOPPED IN TO TROOP MEETING AT OR AROUND 7:00 P.M. WE WERE NOT CERTAIN THAT SHERRARD WOULD BE IN ATTENDANCE; HOWEVER, SHORTLY AFTER ARRIVAL HE CAME OUT OF THE CHURCH SCOUT TROOP MEETING ROOM. WE APPROACHED HIM AND SUGGESTED THAT MAYBE WE COULD MEET PRIVATELY FOR A FEW MOMENTS TO DISCUSS A PROBLEM. HE BECAME SOMEWHAT BELLIGERANT IN HIS ATTITUDE AND STATED THAT HE HAD THINGS TO DO WITH THE TROOP. WE STATED AT THAT TIME THIS WAS OF UTMOST IMPORTANCE TO SCOUTING AND TO THE TROOP HE WAS ASSOCIATED WITH. HE AGREED; AND WE WALKED AWAY FROM THE ENTRANCE OF THE CHURCH AND PROCEEDED AT THAT TIME TO EXPLAIN THAT HE WAS INVOLVED IN A PERSONAL PROBLEM THAT LED THE FIRELANDS AREA COUNCIL TO MAKE A DECISION REGARDING HIS REGISTRATION IN THE BOY SCOUTS OF AMERICA. WE ALSO ASKED IF HE KNEW WHAT WE WERE REFERRING TO; AND HE STATED THAT HE DID.

WE ALSO THEN ASKED IF IN FACT HE DID PLEAD GUILTY TO THE CHARGES SET FORTH EARLIER THIS SUMMER; AND HE SAID THAT HE DID. HE FURTHER STATED THAT HE WAS UNDER EVALUATION AND UNDER MEDICAL HELP OF A PSYCHIATRIST.

HIS WIFE, CATHY L. SHERRARD, CAME OVER TO WHERE WE WERE DISCUSSING THIS PROBLEM AND WONDERED WHAT WAS GOING ON; AND WE TOLD HER WHY WE WERE THERE. AFTER SOME DISCUSSION HE AGREED THAT HE WOULD SIGN A LETTER TENDERING HIS RESIGNATION AS A MEMBER OF THE BOY SCOUTS OF AMERICA AND ALL SCOUTING ACTIVITIES EFFECTIVE IMMEDIATELY. HE THEN ASKED SINCE HE HAD A SON IN SCOUT TROOP 314 IF THIS MEANT THAT HE COULD NO LONGER ATTEND COURTS OF HONOR AS A FATHER. WE POINTED OUT TO HIM THAT STRICTLY IN THE ROLE OF A FATHER HE COULD ATTEND FUNCTIONS OF THE TROOP WHERE PARENTS WERE INVOLVED.

HIS WIFE STATED THAT THIS COMES AS NO GREAT SHOCK. WE WISHED HIM WELL AND THEN LEFT THE MEETING AND THE CHURCH PREMISES.

AS FAR AS I AM CONCERNED, THE MATTER IS CLOSED. HIS NAME HAS BEEN TAKEN OFF AS A REGISTERED MEMBER OF TROOP 314.

I AM ENCLOSING THE LETTER HE SIGNED, AN ARTICLE FROM THE LORAIN JOURNAL, AND A COPY OF THE CHARGES WHERE HE PLEADED GUILTY TO A REDUCED CHARGE.

IF THERE ARE ANY QUESTIONS I CAN ANSWER, I WOULD HOPE THAT YOU WOULD FEEL FREE TO CALL ON ME.



Man charged with girl's rape

LORAIN — A rape charge was filed against a 38-year-old Lorain man yesterday for a complaint police received from a 14-year-old girl.

The city prosecutor's office filed the charge in an arrest warrant for David Sherrard, 3151 Denver Ave. The warrant had not been served as of this

morning.

The girl said she had been raped on a weekly basis from October to about February.

Police interviewed a suspect last week. And, in written statement filed in Lorain Municipal Court, the suspect said he would do what he could to obtain psychiatric help.

I, DAVID A. SHERRARD, the undersigned Defendant in the above entitled action, having been indicted for the offense(s) of:

Sexual Battery, 2907.03 (F-3)
charged in the indictment having been arraigned in open court with counsel thereon heretofore, and having been informed and advised this day in open court by the court and by my counsel that the offense(s) with which I am charged might result in my being confined in the Ohio State Reformatory or Ohio State Penitentiary and the minimum and maximum possibilities of the time of confinement, and having been advised of the elements of the crime, and having also been advised that I have a constitutional right to a jury trial, to confront witnesses against me, to have compulsory process for obtaining witnesses in my favor, and to require the state to prove my guilt beyond a reasonable doubt at a trial at which I cannot be compelled to testify against myself, and whether or not probation can be granted, and that after sentence is imposed, I have a right to appeal; that if I am unable to pay the cost of an appeal, I have the right to appeal without payment; if I am unable to obtain counsel for appeal, counsel will be appointed without cost; if I am unable to pay the costs of documents necessary to an appeal, such documents will be provided without costs; and I have a right to have a notice of appeal timely filed on my behalf, I do hereby knowingly understand what I do now and of my own free will hereby waive said rights and enter a plea of guilty/~~plea of not guilty~~ to said offense(s), as charged herein, or the lesser included offense(s), to-wit:

Sexual Battery, 2907.03 (Felony 3rd degree)

1. Do you understand you are charged with yes
