



Dear Mr. Schuyler:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.



A 52-year-old North Dade scoutmaster was arrested Tuesday after? a 10-year-old Cub Scout said the suspect molested him last weekend during a backyard campout.

Seth Schuyler turned himself in to North Miami Beach police. shortly after midnight after police asked him to come to the station. Schuyler was charged with capital sexual battery on a juvenile and. lewd and lascivious acts with a juvenile.

The 10-year-old boy's mother told North Miami Beach police Monday that Schulyer had molested her son. Police interviewed some of the six other youngsters

en the compout, some of whom said they saw Schuyler molest the

boy, police said.

"Some of them did," said Detective Steve Steinberg, The ages are 8 to 10, so they're real young kids."

Sgt. David - Kelly, also said

Schuyler "admitted to some of the allegations, not all," at the station.

A few months ago, Schuyler took charge of Cub Scout Pack 10, which meets at Natural Bridge Elementary School, 1650 NE 141st St., when membership at that-den was faltering. He is also an assistant scoutmaster with Boy Scout Troop 370 at Holy Family

Catholic Church, 14500 NE 11th Ave. in North Miami, a member of that troop's council said.

Kenneth Tibbett, a den leader with Pack 10 last year, said Schuyler approached the pack's council a few months ago, saying he would revamp the group by combining activities with older boys from Troop 370. Instead, the

den deteriorated, Tibbett said.
"Seth told us he was going to
take over," Tibbett said. "And everything slid downhill from there."

John Malone, field services di-rector for the Boy Scouts, said Pack 10 was listed in his records as disbanded because it was two months past due in renewing its

"They did exist up till June 1," he said.

North Miami Beach police also called Metro-Dade police, who said they will investigate another similar complaint made this week against Schuyler, who lives in unincorporated Dade.

As of Tuesday afternoon, detective had not been assigned to that case, which allegedly occurred during an earlier campout in Schuyler's back yard, police

Schuyler, of 1561 NE 118th St., was in Dade County Jail Tuesday night after being ordered held without bond.

Dade Circuit Court Judge Robert Newman also ordered a psychiatric evaluation and set Schuyler's arraignment for June 25.
