Dear Paul:

I was made aware by Dan Baker, one of my District Executives, of an article in the Worcester Telegram listing a Mohegan Council Scouter as being indicted of a morals offense.

The charge returned by the Grand Jury was rape of a child on July 7th and September 1st, 1985 in Oxford, Massachusetts. The incident involved a 13 year old male.

The scouter named in the indictment is registered as Scouting Coordinator of Troop 101, Auburn, Massachusetts chartered to Auburn 1st Congregational Church, 144 Central Street, Auburn, MA 01501. He is Aubrey E. Pulling, 6 Paul Street, Auburn, MA 01501; D.O.B. 12/33.

Mr. Pulling has resigned his position with the troop according to Dr. Kenneth Knox, Pastor of the church.

I will keep you posted as more information is available.
