OLIVER is a Boy Scout leader in Pinellas County and some time during the past week, had handled and fondled the boy who was a boy scout. The boy brought the matter to the attention of his parents, who subsequently contacted the Sheriff's Office. OLIVER is booked in the Pinellas County Jail with a bond set at \$25,000.00.

SAFETY HARBOR — A 37-year-old Boy Scout troop leader was arrested Sunday night and accused of fondling a 12-year-old boy in his troop.

Donald Duane Oliver of 260 13th Ave. N. Safety Harbor, was in Jail Monday in lieu of \$25,000 bail. Pinellas County sheriff's spokesman Lt. John Bocchichio said Oliver is charged with one count of lewd and lascivious behavior. The incident took place last week at Oliver's home where a group of boys had gathered before a Scout outing, sheriff's officials said.

Oliver was arrested by sheriff's detectives after the child reported the incident to his parents, who notified


law enforcement authorities, officials said.

Oliver, a service station manager, has been involved in scouting for about a year and a half, Bocchichio said.

Scout troops are organized by Independent groups and then chartered by the Boy Scouts of America, a Scout official said. The charters are renewed annually,

Grant Wallin, executive director of Boy Scouts of America in Pinellas County and West Pasco county, said Monday that the organization "preaches constantly that great care should be exercised in selecting leaders. We have a list of guidelines we give to people organizing new troops and hope they will be followed.

"We try to exercise as many safeguards as possible. It's unfortunate when something like this happens."
