Immoral acts conducted with at least 2 members of the summer camp staff at the Theodore L Storer Scout Reservation during the summer of 1971. Rudolph was employed as Waterfront Director at the time.

1. [REDACTED], Program Coordinator of the Camp advised Reservation Director Anthony N Toto of two instances where Rudolph had fondled the genitals of Junior Staff.
2. Toto summoned [REDACTED], 45 Bates Street, Revere, Mass, a staff trainee and [REDACTED] admitted that Rudolph had invited him into his tent had him expose himself and fondled him.

██████ also advised Toto of a similar incident that took place with Rudolph and Staff trainee ██████████ 57 Carol Drive Dedham, Massachusetts.

Toto summoned ████████ and after considerable discussion ████████ did admit that he was invited into Rudolph's tent was asked to expose himself and his genitals were fondled.

Toto confronted Rudolph with the statement that he had received from the staff members and he was asked to resign from the Camp Staff and the Scouting Program. Rudolph agreed and was taken home by Toto.

The above report was submitted by Toto who is Director of Support Services for the Boston Council.

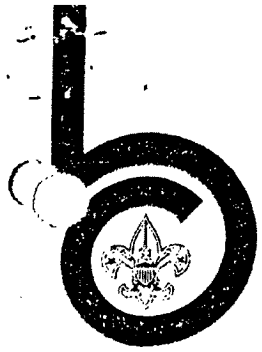
