Mr. Joseph C. Hart at 3641 Cleveland Avenue, St. Louis, Missouri 63111, who is currently registered as an Assistant Scoutmaster, 34 of Troop 852 sponsored by the Compton Heights Christian Church of St. Louis, Missouri, has been asked to relinquish his relationships, commission and registration with the Boy Scouts of America by the St. Louis Area Council.

Through several sources, the most recent, the police files of the St. Louis Metropolitan Police Department, it has come to our attention that Joseph C. Hart has been arrested on ten counts of child molestation, specifically, acts of sodomy on juveniles. He was charged on four counts and rather than a court deposition he voluntarily underwent treatment. The latest charge was as recent as 1968. He has been personally identified by one of our staff people from police files.

Mr. Hart is approximately six feet tall, Caucasian, very heavily built in the vicinity of 235-245 pounds, light hair and speaks with a sort of a country drawl.

We are requesting that he be placed on the confidential file list of the National Council, Boy Scouts of America.
