I am sorry to have to bring to your attention a situation which developed in Boy Scout Troop 12 this past week. I was informed of this by a letter from the boys, a copy of which is included for your perusal. I think it explains quite well the incident which occurred. Mr. Robert Russell, a systems analyst in the personnel department of The Univ. of Michigan has been our assistant Scoutmaster for the past several months. He is knowledgeable concerning Scouting goals and served in a positive manner until this past August. However during that weekend he displayed very filthy pictures to some of the younger boys in an effort to excite them and caused several of them to be taken where he attempted to molest them. Upon

THANK YOU IMMENSELY, [redacted]

I, J. I. Please understand, we do not wish to hurt Mr. Gessel. He is very nice, but many members with whom we have spoken with, and ourselves, feel that the troop would be better off without such an influence. We also do not wish to embarrass [redacted] or make it hard for him, but we can hardly make such an accusation without concrete evidence. We're sorry, but we hope you understand.
