Ex-Scout Leader Indicted

MOUNT HOLLY.—A former Boy Scout troop leader was indicted Tuesday by a grand jury on four counts of sodomy and impairing the morals of minors.

Louis Schwartz, 40, of the Kings Highway Towers, Maple Shade, was allegedly involved with four young boys in Medford between the summers of 1971 and 1972.

Schwartz has been freed in \$5,000 bail.

Sodomy Charged To Scoutmaster

MOUNT HOLLY — A Burlington County scoutmaster was indicted yesterday on four counts of sodomy and impairing the morals of minors for offenses involving four young boys.

Louis Schwartz, 40, of Kings Highway Towers, Maple Shade, was named in a true bill submitted by the grand jury to Superior Court Judge W. Thomas McGann.

Burlington officials reluctantly confirmed reports that Schwartz was a scoutmaster, saying they thought publication of the fact would unfairly discredit the thousands of moral men who work in the scouting movement.

The alleged sodomy offenses occurred in the summers of 1971 and 1972 with four boys who were Boy Scouts. They were not, however, members of Schwartz's troop.

Man, 40, indicted on morals counts

MOUNT HOLLY — A 40-year-old Scout leader man has been indicted by the Burlington County Grand Jury on four counts of sodomy and impairing the morals of minors.

Louis Schwartz, of the Kings Highway Towers, Maple Shade, was charged with committing sodomy with two 12 year old

youths, one 11 year old and a 10 year old youth, according to the indictments handed up to Superior Court Judge W. Thomas McGann earlier this week.

According to the Burlington County Prosecutors Office, the alleged incidents occurred between the summer of 1971 and the end of the summer of 1972.

Prosecutor Dominick J. Ferrelli confirmed that Schwartz is a Scoutmaster, Cub Scout leader, and chaplain at the Lenape Reservation, but stressed that Schwartz' alleged actions should not be taken as a reflection on the scout movement.

Ferrelli said none of the boys involved were from Schwartz's troop.

Schwartz, who is married and has one daughter, is presently free on \$5,000 bail set by Superior Court Judge Edward V. Martino.

I would like to call to your attention a number of incidents that occurred during the month of August, 1972, which involved the above named subject.

It is my understanding that Mr. Schwartz is associated with the Boy Scouts of America in the capacity of Scout Master, Cub Master, and Chaplain of the Lenape Reservation.

He was just indicted by the Burlington County Grand Jury on a number of charges of debauching the morals of a minor, in that he did engage in a number of acts of sodomy and oral copulation with young boys. Mr. Schwartz has admitted to these acts and is presently awaiting trial.

I am certain that you will not want to have Mr. Schwartz continue in the capacity in which he is serving.
