

After the boys had returned from skating we overheard the boys talking about this happening. We started asking questions and found that the same thing had happened before and with other boys.

We reported it to the Police Captain, Gary Pedigo, and he called Edson Merlau in, to the Police Office, and confronted him with the information and Edson Merlau admitted it had happened.

Mr. Merlau promised Captain Pedigo that he would withdraw from all activities where young boys were involved. It is our feeling that he should not be allowed to take any active part in Scouting in the future.

Dear Sir:

On February 16, 1972 a Hoisington man contacted me at this department and advised that his four sons on the previous Saturday had went ice skating on a farm pond north of Hoisington with Assistant Scoutmaster Edson Merlau. The oldest boy (age 13) broke through the ice and was taken to the car by Merlau to take off his wet clothing and and to keep warm, during this time Merlau fondled the boy's penis. The Hoisington man also advised his son told him this had happened on several other occasions over the past two months, which also included his eleven year old brother. According to the father no harm was done to his sons and the matter was to be dealt with at my discretion. In view of the extreme damaging results which might be suffered by all concerned this incident was handled within the department by myself with no charges being filed at this time against Edson Merlau.

Edson Merlau was contacted on February 17, 1972 and asked to come to the Hoisington Police Department, at which time he did. Merlau was asked about the incidents described above, he stated he had fondled the boy at the farm pond, but denied any contact with the other boy at anytime. Merlau also related fondling another boy last summer during a scout camping trip, but advised the boy was fully dressed and that he and several other boys were wrestling inside a tent. Merlau advised he had this problem for some time, however at no time did any harm or sexual act take place with any boys.

It was suggested to Merlau at this time to seek professional help for his illness, and in view of the possible damaging results to scouting along with the opportunity for this to happen again, for him to resign from scouting and all related youth involvment. Merlau was also told if this type of behavior was brought to my attention again that criminal charges would be filed. Merlau stated that he would resign his position in scouting as well as other youth involvment, and if his illness continued, he would seek professional help.

Mr. Ray Humphrey in the scouting program at Hoisington was contacted along with the father and mother of the boys involved, and were advised of the action taken, they were all in agreement at this time.

I hope this will be satisfactory for all concerned to continue a normal and productive existance within our community. If I can be of futher assistance in the future, please advise.
