Dear Mr. Ernst:

This is a follow-up letter related to our telephone conversation Thursday, July 20, 1972 concerning a sex perversion act at Camp Sandscrest on Wednesday, July 19, 1972.

The person involved is John C. Gower, Scoutmaster of Troop 82 sponsored by the P. T. A., Glen Dale Elementary School in Glen Dale, West Virginia. Mr. Gower, a former professional scouter, was assisting with the summer campfire programs at camp on Wednesday and Friday evenings. Two hours after the campfire program his car was observed parked on the camp road near a campsite. The Camp Director [REDACTED] and Program Director [REDACTED] were contacted and went directly to the campsite to observe any irregularities. They detected a noise from one tent and [REDACTED], shining a flashlight into the tent, opened the front flap and observed Gower on his knees with his head in a boy's crotch. [REDACTED] told Gower to stand still; however, he ran out of the rear of the tent and into the wooded area. He was followed by flashlight by [REDACTED] and [REDACTED]. They then removed the rotor from his car distributor so the car would be unmovable, put a note on the windshield to report to the camp office and called me at 1:30 a.m. to inform me of the above events.

I contacted Wayne Julian, Area Representative from East Central Region and former Scout Executive of the National Trail Council who was on vacation in Wheeling and we went directly to camp. Mr. Gower was waiting on the porch of the lodge. [REDACTED] and I personally talked to Gower who was quite belligerent; however, after the facts were presented to him, he cried. I gave him two alternatives: (1) to resign immediately as a member of the Boy Scouts of America and to seek psychiatric assistance or (2) to report him to the local police authorities. He agreed to the first proposal.



Once on the road, Mr. Campbell will be in charge.


And if that is not enough let me make one additional announcement. An announcement that I had hoped to put off until after the trip to Haliburton, but may as well get off my chest at this time. It took me about one month after signing on as Scoutmaster of Troop 82 to realize I'd made a big mistake. Just too many boys for me to handle, even with the two good assistants. And the situation has been compounded by other factors.

In the interest of time let me just say that for personal reasons I am resigning, as of this writing, as Scoutmaster of Troop 82. Please! This is hard enough for me as it is. Don't make it any harder. Do not telephone or send a committee to try to get me to change my mind. It is a hard decision for me but one that is irreversible. Let it go at that - please!

I know this leaves ^{things} very much up in the air but you'll have time to find my replacement before the fall meetings are scheduled to begin. I want to thank all of you for your interest, assistance and cooperation. Much appreciated.

Report of apprehending a homosexual at Sandscrest Scout reservation at Coon Holler campsite between 12:00 and 1:00AM, July 20, 1972.

Due to recent reports of homosexual activities and certain methods of operation of the homosexual, the Camp Director and Program Director at Sandscrest had reason to suspect Jack Gower as a possible offender.

When Gower left camp after helping with the Wednesday night (July 19, 1972) campfire program, close attention was paid to his departure. It was observed that he was the last non-camper to drive out of the entrance road at approximately 12:00PM.

Because of the recent homosexual reports and their suspicions, the Camp Director, [REDACTED] and the Program Director, [REDACTED] thought it prudent to walk to the mouth of the entrance road to check for parked vehicles.

Rounding a bend in the road an orange V.W. was observed parked on the right side of the road near a break in the fence directly above the Coon Holler campsite. Closer investigation proved the car to be unoccupied.

We then quietly approached the Coon Holler campsite. After silently observing the camp for several minutes we approached the western most tent. While approaching [REDACTED] thought he heard sounds and both men stopped. After a pause of about 1 minute [REDACTED] approached the front of the tent and drew the flap back flashing a flashlight inside. Jack Gower was observed squatting beside a boy in the right side cot ([REDACTED] T-155) with his back to [REDACTED] at approximately the middle of the cot. On observing Gower, [REDACTED] said "Jack, don't run." Jack rose and without turning ran out of the rear of the tent. [REDACTED] standing by the left side of the tent observed him run out of the back and [REDACTED] flashed the light on him as he ran into the woods.

Report of action taken on the evening of July 20, 1972 by the staff
andscrest Scout Reservation concerning homosexual activity in the
camp.

At approximately 11:30 P.M. the camp director, [REDACTED] informed
the program director [REDACTED] of a report of homosexual activity as
reported by a scoutmaster from the preceding week. The camp director told
the program director that he ^{had} reason to suspect Jack Gower as the offender.

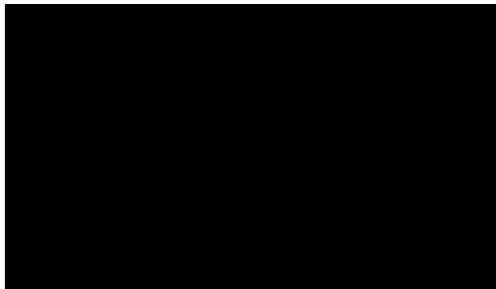
After observing Gower leaving from the area of the lodge, the camp
director and the program director decided to walk out the camp road to
investigate. Approximately one half the distance to G C & P road from the
lodge, [REDACTED] and [REDACTED] observed an unoccupied orange Volkswagen with
West Virginia plates parked alongside the road. They proceeded to walk
through Buckskin site and into Coon Hollersite. [REDACTED] then stated that he
thought that he observed a light coming from one of the tents. The two
approached to within 30 feet of this tent. [REDACTED] stated that he thought
he heard movement within the tent. He took a flashlight, threw back the
flap of the tent, and shined the light into the tent. At that time [REDACTED]
was approximately 30 feet to side of the tent. Immediately after [REDACTED]
had shone the light into the tent, a large man who distinctly resembled
Jack Gower ran out the back of the tent. [REDACTED] spotted him with the light
and shouted " Jack don't run." The man ran off into the woods. [REDACTED] and
[REDACTED] then returned to the parked Volkswagen, removed the distributor
rotor, and returned to the lodge. The two then asked two adult staff
members to come to the lodge. These were Bill Price and George Morse.

Report of homosexual activity at Indian Ridge camp-site July 1, 1972.

During the morning of July 1, 1972 reports were made to the camp staff by members of T-266 and several Scouts staying with that unit that they were molested by a homosexual at approximately 12:00AM the morning of July 1.

The following are from personal interviews with [REDACTED], Camp Director.

[REDACTED]

GENERAL DISCREPTION: white shirt, dark slacks, male

- D.L. A male entered my tent and played with my penis for 10 to 15 minutes.
- D..V. Asked, "did it feel good," covered my eyes...big man I think.
- E.C. A big guy unzipped my sleeping bag and touched my crotch.
- M.R. A male put his hand in my pants. Said his name was Bob and he lived down the road. Either a big boy or a small man.
- I.C. Curly black hair....big man touched my crotch for 15 minutes. He repeated "how do you feel, how do you feel." He wore a white shirt, dark pants and stuffed the sleeping bag in my mouth.
- M.D. He covered my eyes, touched my penis, kind of tall not small.

THE GENERAL METHOD OF OPERATION SEEMED TO BE TO ENTER THE TENT, COVER THE BOYS EYES WITH ONE HAND OR FLASH A LIGHT IN THEIR EYES. THERE APPARENTLY WAS NO ORAL CONTACT, JUST HAND PENIS CONTACT. NO ONE CAN IDENTIFY.
