Goldstraw confessed to charges of debauching the morals of a minor, indecency, and lewdness. Charges made by [REDACTED], age 13 and his mother both residing at 216 Front Street, Mt. Holly, New Jersey. [REDACTED] at the time was a member of Troop 99 at McGuire Air Force Base. Goldstraw was acting Scoutmaster of the troop although he had not registered as he had just arrived at McGuire AFB from Ramey AFB, Puerto Rico. Goldstraw also confessed to performing acts of sexual perversion with boys while stationed at Ramey AFB. (over)

The charges brought by the [REDACTED] were made as a result of perverted sexual acts performed at Camp Lenape, Burlington County Council, during the third week of July, 1972.

Goldstraw is now under psychiatric care at McGuire AFB. Major George G. Lothian attending. He is responding well to treatment and will probably remain in Air Force and be returned to active duty.

Public Defender, Andrew J. Rodnite on 9/7/72 has recommended that charges brought against Mr. Goldstraw be lessened.

Goldstraw is the 3rd child of three children. His father was killed in World War II. Goldstraw lost a son when the boy was three years old. He and his wife separated for several months about 10 years ago.
