ON OR ABOUT OCTOBER 1ST, WE NOTICED AN ARTICLE IN THE ELYRIA CHRONICLE INDICATING THAT HE HAD BEEN ARRESTED FOR FELONIOUS ASSAULT.

ON OCTOBER 19TH, HE APPEARED BEFORE THE LORAIN COUNTY COURT AND PLED GUILTY TO ENTICING A MINOR. I ASSUME BECAUSE OF THE WAY THE COURTS OPERATE TODAY, HE PLED GUILTY TO A LESSER CHARGE OF A MISDEAMEANOR. ON OCTOBER 25TH, OUR CATHOLIC COMMITTEE CHAIRMAN AND MYSELF MET WITH HIM. WHEN CONFRONTED WITH THE CHARGES THAT ARE DOCUMENTED, HE AGREED TO RESIGN FROM THE BOY SCOUTS OF AMERICA.

I AM ENCLOSING HEREWITH, ALL SUBSTANTIATING INFORMATION.

I WOULD APPRECIATE YOUR RECOMMENDATION ON FURTHER PROCEEDINGS RELATED TO OUR CONFIDENTIAL FILE.

2903.01. Assault upon a minor.

No person over the age of eighteen years shall assault a child under the age of sixteen years, and willfully take indecent and improper liberties with the person of such child, without committing or intending to commit the erime of rape upon such child, or willfully make im-proper exposures of his person in the presence of such child.

2903.09 Trustee for dependent child or pregnant wife of person convicted of shandonment, torture or neglect.

When a person is convicted sentenced, and confined in a workhouse or county Jail under section 2003.08 of the Revised Code, the county 150m which he is an convicted, sentenced, and confined, upon the warrant of the county auditor, and out of the gentral towense fund thereof, shall pay monthly, to a trusted to be appointed by the court imposing such sentence, fifty earls for each day the prisoner is no confined, to be expended for the maintenance of the child under eightfen years of age, or the physically or mentally handicappied child outer the age of twenty-one years, or his pregions wife.

Any humans sanciefy incorporated and existing under the laws of this state, or any other shifted person, who is willing to serve as trustee winder this section for the henefit of such child or children. No person shall knowingly distribute, lend, give a kay, exhibit, sell or offer to distribute, lend, give a way, takhift, or sell, to or for a minor under the age of eighteen, pyinted or reproduced material in a newspaper, magazine, or in eartoon form commercially known as a "comit wook" or "somie magazine"!

(A) Depicting any unlawful act of murder, killing shooting, cutting, stabbing or maining of a person or any act of robbery, burgiary, rape, seduction, input, seducy, prostitution, pandering, kidnapping, arang forgery, counterfeiting, treason, or use of nercotics;

(B) Alpenting acts of unusual crueity or may or extreme britaility;

(C) Adheeaing acts involving moral turpitude;

(D) Which is provocative of corrupt mergis, crime, or juvenile delinquency.

Possession of any of the above constitutes primafacie devidence of knowledge.

This section does not apply to depicting of biblical or historical events.

Whoever violates his section shall be fined not more than one thousand deliars, or imprisoned not more than six months, or both.

2903.12 Enticing away a child under sixteen years.

No person over the age of eighteen years shall detain, lead, take, carry, or entice away a child nucler the age of sixteen years, with intent to commit any offense under section 2003.01 or Chapter 2005. of the Revised Code.

Whoever violates this section shall be flared and more than five hundred dollars, or imprisoned not more than six months, or both. (130 v H 607. Eff. 10-10-63)

(A) Any material or performance is "hapaful to minors," if it colitains a description or representation in any form of multy, exami conduct, ox-fexual excitement, if it is offensive to prevailing standards in the adult community with respect to what is suitable for minors, and if it lacks sufficient seientifie, educational, sociological, mural, or artistic value for minors to outweigh its harvaful qualities.

(B) "Minor" means an unmarried person under the age of eighteen years.

(C) "Obsecusy" "multity," "sexual excitement," "sexual conduct," "material," and "performance" have the agents meaning as provided in section 2005.34 of the Revised Code.
