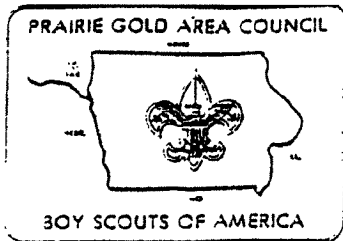

Dear Paul,

The attached copy of the minutes of a meeting of the town officials of Smithland, Iowa has just come to my attention. In it, action is taken against a man named Gilbert Reinbold. Mr. Reinbold, up until very recently, was registered as a member of the troop committee and pack committee of Troop and Pack 273 in Smithland, Iowa. These units have dropped in the past 60 days, and we now expect to reregister them without Mr. Reinbold.

I understand that the final disposition of the case against Mr. Reinbold was as follows. No formal action was taken with the understanding that Mr. Reinbold would leave the community. He has left Smithland, Iowa. It is my understanding that he is moving to California. It seems to me wise that we should place Mr. Reinbold in our confidential file against the day that he might try to register with the Scouting program in California where he is not known. To the best of my knowledge, he is not now registered in any capacity in Scouting.
