The above man, it is rumored has had charges of a moral nature while in service. They were dropped upon intervention of Chaplain.

After I received the enclosed, I found this man had been meeting with a Scout Troop in Newport News. He avoided registering with unit when he would explain that he was registered on a Council level. Unit believed him and never checked. I also had him come to my office and I confronted him with the statements in letters. He asked if I could name the youngsters, I said no and posed the question if he was in doubt how many more violations of boys in unit were there.

When I asked why he didn't register, he said he couldn't because he was an Atheist. I informed him to stay away from any Scouts and units in this Council on both items and I also informed him that we would not (this Council) accept a registration. There is no doubt in my mind the charges are valid and registration or affiliate with boys should be stopped.
