The above-named defendant having heretofore, on October 26, 1973  
been convicted of the crime of Lewd & lascivious (288 PC)

as charged and set forth in a ~~(Indictment)~~ <sup>(Complaint)</sup> entitled and numbered as above, filed in said  
Court by the District Attorney on ~~(Information)~~ <sup>(Complaint)</sup> October 5, 1973  
and this being the time fixed for pronouncing judgment upon the defendant, the People  
appearing by William Gentry Deputy District Attorney,  
and the defendant appearing in person and by Joel Golden  
attorney, and it appearing to the Court that the ends of justice will be served by placing said  
defendant upon probation;

IT IS THEREFORE NOW ORDERED by the Court that the ~~(Imposition)~~ <sup>(Imposition)</sup> of sentence upon  
~~(suspension)~~ <sup>(suspension)</sup>  
the defendant be and the same is hereby suspended for the term of Five (5) years  
from the date hereof, during which time the defendant is committed to the charge and super-  
vision of the Probation Officer of said County of San Diego and of this Court;

IT IS FURTHER ORDERED that said defendant wholly abstain from violating any of the  
laws of the United States of America, and wholly abstain from violating any of the laws of the  
State of California, and wholly abstain from violating any of the ordinances of any municipal-  
ity within this State; that defendant wholly abstain from engaging in criminal or unlawful  
practices of any kind; that defendant conduct him self in all respects as a reputable and law-  
abiding citizen; that defendant not depart from the County of San Diego during said term of  
probation without the consent of the Probation Officer, nor from the State of California with-  
out the consent in writing of one of the Judges of the Superior Court of San Diego County;

That said defendant report to the Probation Officer at such times and in such manner  
as directed and follow such course of conduct as may be prescribed by the Probation Officer;

1. Participate in a program of counseling and/or therapy as recommended by Probati:  
Officer and that he authorize the counselor or therapist to submit periodic  
reports of progress to the Probation Officer and is not to terminate said pro-  
gram without permission of the Probation Officer in writing and order of the  
Court;
2. Not be in the company of minors under the age of 18 without the presence of an-  
other responsible adult;
3. Register pursuant to the provisions of PC 290;
4. Be permitted to travel to and reside in Alameda County, California and that  
immediately upon establishing residence there he notify the Probation Officer,  
who is then directed to take such steps as necessary to initiate transfer of  
jurisdiction to Alameda County pursuant to PC 1203.9;

You are hereby informed that:  
Every defendant who has fulfilled the conditions of his probation for the entire period thereof, or who shall have been dis-  
charged from probation prior to the termination of the period thereof, shall at any time thereafter be permitted by the Court to  
withdraw his plea of guilty and enter a plea of not guilty, or if he has been convicted after a plea of not guilty, the Court  
shall set aside the verdict of guilty; and in either case the Court shall thereupon dismiss the accusation or information against  
such defendant, who shall thereafter be released from all penalties and disabilities resulting from the offense or crime of  
which he has been convicted
