PROBATION ORDER

The above-named defendant having heretofore, on October 26, 1973 (288 PC) been convicted of the crime of Levd & lascivious

as charged and set forth in a (Complaint) entitled and numbered as above, filed in said (REMERERALEX

Court by the District Attorney on October 5, 1973 and this being the time fixed for pronouncing judgment upon the defendant, the People appearing by William Gentry Deputy District Attorney, and the defendant appearing in person and by Joel Golden attorney, and it appearing to the Court that the ends of justice will be served by placing said defendant upon probation;

IT IS THEREFORE NOW ORDERED by the Court that the [Imposition] of sentence upon

the defendant be and the same is hereby suspended for the term of the defendant be and the same is hereby suspended for the term of Five (5) years from the date hereof, during which time the defendant is committed to the charge and supervision of the Probation Officer of said County of San Diego and of this Court;
