We have a tape recording by the child and the family is willing to make a written statement if necessary. The troop committee has met under the leadership of the District Chairman and Paul B. Hill has been relieved as scoutmaster. Paul B. Hill has been confronted with the charges and will not deny the charges but also will not say they are true. Paul B. Hill has indicated he will be moving to Mobil, Alabama soon and will try to get back in Scouting in that area.

The Houston County Sheriff Department is the one that brought all this to our attention. We have the necessary information to recommend that he be denied ever registering with the B.S.A.
