


Dear Paul:

Please place [REDACTED] registered as a District Committee Member-at-Large of [REDACTED], on the confidential file for reasons of homosexuality. Action was taken as a result of the attached letter from Ernie Mehlhorn, Scout Executive of the Rio Grande Council in [REDACTED] Texas. A special committee of volunteer Scouters of this Council, including an attorney, met and reviewed the letters and information that we had received from [REDACTED] regarding the boy involved and recommended that the Council President prepare a letter indicating that [REDACTED] was no longer eligible for membership in the Boy Scouts of America. This letter was hand delivered by me to [REDACTED] at 6:00 p.m. on June 23, 1977, in the presence of [REDACTED], our Lay Lodge Adviser to the Order of the Arrow.

In a private conversation following delivery of the letter, I indicated the reason behind this action. [REDACTED] did not deny it. He did admit to me that he was a homosexual but claimed that he had no such relations with [REDACTED]

We, therefore, have removed him from our records and ask that you do the same. To the best of our ability we have completed the confidential record sheet. Enclosed is a copy of the minutes of the special Ad Hoc Committee meeting and the letter directed to [REDACTED]

Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be reinstated.

That was nice of him and I really appreciate that. He did ask me to direct the band again next year, so it looks like you are stuck with me for another year. I do hope they decide to have the two areas together again. If not you will have to let me know when they are having yours so I can plan on being there. That's the best reason I can think of for getting away from here for a couple of days.

I trust everything is back to normal after the sessions at the conference. It is on this end, but you went through more than I did and it was expected to take you longer to get over it. One of these days we will have to re-negotiate the entire thing so that we both carry the same load.

Let me know if you come up with something better on that one. I have thought of a couple of ideas that you might be interested in. I will pass them along later though.

For a while, you can send letters to me here at work. The address will be ██████████ Night Auditor, and the address at the bottom of the page. I will get them here and they will not be opened until I open them.

There is a Texas Indian Hobbyists' pow-wow in the Kerrville Texas area within the next couple of months. I will send you

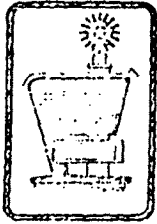

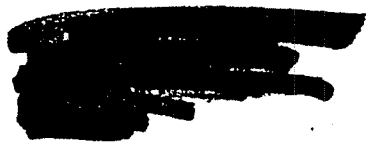
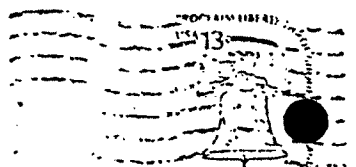

Friday Jan, 28, 1977

First, I would advise you to burn this letter after you read it, or at least hide it very well, so it will not fall into the wrong hands. This one should be a real winner, and will contain several ideas that we want to remain just between us two.

This is started after I talked to you on the phone, because I wanted to add to what I had already written before I called.

I have figured out how to tie someone for the mummy effect, and I will put the system on a separate sheet so you can keep it for later, (especially since I will probably be the first one it will be tested on).

I am also going to list several of the penalties I have thought of so they can be used when we get together. I am sure there will be some that cannot be used on one or the other of us. Where these are listed, we can just make a note of that fact on the list, and that will stop the penalty from being used for that person. That doesn't stop it from being used for the other person though, so there should be several good ones for each of us to use. If you can think of a good penalty to add it to the list. Add it to the list even though you do not want it used on you. If we have not put it on the list, we cannot use it without permission from the person tied up, and that would not be kosher. If it is on the list, and not marked that it cannot be used, then we assume it is ok to use and can go ahead with it. Remember, once a person is tied down and blindfolded and gagged, there really is no way to complain about the penalty used, is there. For that reason, make sure you have already marked all the penalties you do not want used on you. I wouldn't want to make a mistake and use something you didn't want used, just because you hadn't marked, would I? (ha, ha, ha).

The next time we are doing this sort of thing I want you to be as good with the ropes as you can be and therefore we will be more closely matched than before, and neither of us will have the advantage. That will make it more fun than ever.

In every letter, I will give you several ideas how to tie someone, and the penalties you can use when the person is tied this way. That should give you some more ideas even from there. I will always put them on a separate sheet from the letter, so you can save those.

I have some ideas for things you will like.

I have a method of using the spread eagle position that i cannot even start to get out of. This is a handcuff on the end of a nylon strap with a buckle at the other end. The handcuff is placed on the leg on the wrist, and the other end is fastened around the bed post or leg, and there is not way to get out of it. I am sure you will find that handy.

I also have another idea I will try to work on. I have seen a pair of leather underwear. If a lock could be placed on these so that they could not be removed with out the key, this could be used to some advantage by us. I will try to get two of these. If you have the key to the ones I am wearing it and I have the key to the ones you are wearing, then we will be very sure that the other person is not removing the tape before the contest is ended. Also, where there are time limits placed on a penalty, the person could be placed in this and could not possible remove the item before the key was issued. Let me know what you think of that idea.

I also have some other ideas on how to tie up for the penalties that I will give you in other letters. write the ideas you have down and we will compare them in the next phone call.

also what we really need to come up with is some other contests so that they will remain interesting and challenging. If we have some time to get to the conclave and can room together we should have plenty of chances for each other. I am really looking forward to this and cannot really wait. I wish there were some way for us to get together and try out some of these before then. I am still working on that one. I will call soon.

be bad and think bad, (but not too bad).

Penalties used here:

mummy effect with rope

painting

shaving

General description:

hands and elbows tied at sides of the body

(almost every penalty can be used while tied this way. The person can be tied standing, and the penalty used, or can be laid down on front or back and penalty used, and can also be turned over so that different things can be done to front and back. -- the one drawback to this one is that it takes a lot of time to tie correctly. The main good thing about this method of tying is that it would be fairly comfortable for a long period of time, and almost anything can be done to a person while tied in this manner.

1. win the contest so you can tie the other person instead of the other way around.
2. have the other person remove all his clothing, then stand up.
3. use the blindfold and gag at this point.
4. take a length of rope, (about 3 feet 1 figure), and tie it around the right wrist in a square knot. Tie the wrist in the middle of 1 the rope.
5. hold the wrist down at the right side and run the two ends of the rope around in front and behind the right leg. tie it on the inside of the leg with a square knot.
6. wrap the rope around the balls on each side and tie the rope in a square knot on the other side of the balls.
7. take the ends of the rope around the sides of the left leg and tie on the outside of the leg in a square knot.
8. place the left wrist beside the last knot ties and take the ends of the rope around the wrist and tie another square knot on the inside of the wrist.
9. take the ends of the rope up to the right side just above the elbow height, and tie another square knot between the arm and the body
10. take the ends of the rope around the elbow and tie another square knot just below the last one tied. (between the arm and the body.)
11. take the ends of the rope around the body and tie another square knot on the left side of the body in the same position as in number 9
12. wrap the ends of the rope around the left elbow and tie on the inside of the body.
13. If you have more rope, take the loose ends back down to the right wrist and start the entire process over again.
14. If not, then take another piece of rope and continue as listed on the other side.

15. tie a rope around the neck with a square knot and move the rope until the knot is above the right shoulder.
16. run the rope around the sides of the shoulder and tie a square knot just below the knots you tied earlier at the right elbow.
17. wrap the rope around all the knots you tied at the right elbow, and tie in another square knot.
18. take the ends of the rope down to the left wrist and tie a square knot below the knots you have tied earlier.
19. wrap the knots with the rope and tie another square knot.
20. take the ends of the rope over to the right wrist and tie a knot below all the knots you have tied there.
21. wrap the knots and tie another square knot there.
22. take the ends of the rope up to the left elbow and tie a square knot above all the knots you have tied there.
23. wrap the knots and tie another square knot below all the knots there.
24. take the ends of the rope above the left shoulder and tie a square knot.
25. take the ends of the rope around the neck and tie another square knot.
26. you have the person pretty well tied at this point, however, you should also tie the person at the ankles and at the knees before you start the penalties. That way there is no way the person can ever move much less stop you from doing anything. Remember that you will also have to move the person to the bed and lay him down, as there is not a way in the world for him to do it. Do not leave the person standing unless you are right but there working on him, as he cannot keep his balance very well, and there is no way for him to protect himself in case he started to fall.

Penalties used here

almost all, except the mummy and such. for that they need to start from a standing position so you can use the tape.

General description:

spread eagled to a bed

1. win the contest so that you can tie the other person instead of the other way around.
2. have the person remove all his clothing before you start.
3. use the blindfold and gag at this time. The reason for this is so you can go ahead with the penalty and the person does not know what penalty you are going to use. with the gag, he cannot complain, and with the blindfold, he still doesn't know what you are doing. He can only feel what you are doing as you are doing it.
4. have the person lay down on the bed, in the center of the bed.
5. take a piece of rope, (on the special equipment I will describe later), and tie each hand and leg to a different corner of the bed. If you do this correctly, the person cannot get loose, and can stay tied in this position for a long time without being uncomfortable.
6. Remember that after the person is tied in this manner, you will have to be able to do everything in the penalty from this position. Once you have untied him, the penalty is over for the most part except for the time period you have imposed for the penalty.

There is a variation you can use with this one though, for additional things to add to the penalty. Loosen one leg at a time and take the end of the rope up to the head of the bed, around the same place you have the hands. move the other leg in the same manner. tighten both leg ropes, and you have the person in a very open position for other things. You can then use shaving cream in the ass hole or cornhole the person, or whatever you wish to do, as the ass is very exposed and cannot be protected by the person tied down at this point. This is very good because when you first tie the person to the four corners, he will have no idea that you can change the position to this one, and there is no way he can prevent you from doing it.

Penalties I have thought of at this point.

1. use the acrylic paint on some parts of the body, and leave it on for a period of time or until the next win.
2. tape on some of the body for a period of time or until the next win.
3. shaving cream up the ass for a period of time or until the next win. (with this you will have to use some tape to keep the cream there until you want it removed.)
4. Plastic wood is good because it starts out as a paste and will harden over a period of time until it is like plastic or wood. It can be removed (with some effort) without shaving the hair where it is placed. It takes from about five minutes to about an hour to dry depending on the thickness used.
5. an electric blanket can be very effective, if the person wrapped with it is tied up and cannot turn down the heat or remove the blanket. That can be quite a sweatbox.
6. you can shave parts of the body at a time, like the legs, under the arms and the area around the balls and that will become a good one for several penalties, instead of only one. Unless changed by the time we get back together, the only area you can shave on me is under the arms. Also don't forget that you can use the nair for a better and safer, and easier job of removing the hair from the body. (besides that, it takes a little longer for the hair to grow back out with the nair..)
7. the mummy with the tape is a good one.
8. you can add shaving cream and the electric blanket to the mummy.
9. contraband the person can be used.
10. if you are feeling pretty mean, you could make the loser suck you off after you have him tied up.
11. if you know what a catheter is, then you know another one. This is a plastic tube that drains the piss from a person into a bottle or something while in the hospital. The victim could be tied down and have to stay there until he has filled up the bottle or something. If there was another tube for the person to suck coke or beer or something through like a straw then he could hurry the process along. The best part comes when he has ~~the~~ the bottle filled, and then has to stay tied for another 30 minutes with the tube from his dick taped into his mouth. If he can stop from having to take a piss then for 30 minutes, he will be alright. There is the best part. You have to drink enough to fill the bottle, but not enough that you can't stop the action. Sound good.

12. I just thought of a good one. Have you ever broken a bone? do you know how the plaster cast is made? That would make a good penalty for us to use over a longer period. You take some plaster of paris and soak some gauze in it. then you wrap the gauze every where you want the cast, and let it dry. It will harden and form a cast. you could even form a mini cast in the area of the balls that would have to stay for a day or so, if you left the person a way to take a piss with it on. This could be another use for the catheter. you form the cast with the tube in the dick and run the tube down the pants leg. when the person has to take a piss, he merely takes the tube out and takes a piss.

the cast can be removed by soaking in the tub for a while. the plaster will soften in the water and the gauze can be unwound.

how does that sound for a good one?

Especially, what would happen if the victim had a soft dick when the cast was applied and then later after it was hard got a hard on? ouch, that could hurt some.

I hope you have some ideas for good penalties for me, to add to this list. I am sure that all the penalties cannot be used on both of us, but I have listed them anyway. Maybe even if I didn't mind the penalty you would not want to use it. ~~Even~~ that is ok too. the decision about what penalty is up to the winner each time. Be sure you mark anything you do not want used on you. That way I will know when we compare lists, and won't use them.
