Thank you for the information concerning the above Scouter. We have reviewed this case with our Attorney and placed this man on the Confidential File.



Dear Mike:

After careful review, I have decided that your registration with the Boy Scouts of America should be suspended. I am, therefore, compelled to request that you suspend all relations that you have with the Boy Scouts of America, including your relationship with Troop 312, sponsored by the Nativity BVM Roman Catholic Church in the Philadelphia Council.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. It reserves the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the Boy Scouts of America seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining why you claim that your registration as a BSA leader should be reinstated.

Scout Chief Convicted

Λ 29-year-old assistant scoutmaster yesterday was convicted of sexually molesting one of his charges a 12-year-old boy — last May 5.

Assistant District Attorney Adam Renfroe said the defendant, Michael Pyatt, showed two porno-graphic films to the victim and another 12-year-old in Pyatt's home on Belgrade St. near Clearfield, and molested the boys.

, He was acquitted of one of the

molesting charges.

Pyatt said he may have made on "error in judgment" by showing the films but denied molesting the boys. He was released on \$4,000 bail. Sentencing was deferred.

Scouter Guilty in Sex Case

An assistant scoutmaster was convicted yesterday of sexually molesting two boys in his scout troop.

Michael Pyatt, 29, of the 3000 block of Belgrade st., Philadelphia was convicted of two counts of indecent assault and one each of involuntary deviate sexual intercourse and corrupting the morals of a minor.

The verdict was handed down yesterday by a jury that deliberated for most of two days following a four-day trial before Common Pleas Judge Charles Klein.

According to testimony at the trial, Pyatt had invited two 12-year-old boys that lived in his neighborhood and were members of his scout troop to watch pornographic movies at his house on May 5.

One of the boys, whose names are being withheld, testified that Pyatt molested him after the movie.

A short time later while he was in Pyatt's bathroom; he said. Pyatt came in and performed sexual acts with both boys.

The boy's mother testified that she became suspicious when (and went to investigate), when her her son did not return right away from Pyatt's house.

She said Pyatt told her that neither of the two boys was there although she later found out that both were there at the time.

"had judgement" in showing the porno films to the boys but his only concern was to help prepare them for life.

He also admitted lying to the boy's mother, when she came to the door. But he denied touching either boy or having sex with them in any way.

Assistant District Attorney Adam Renfroe. It, explained that the one count of indecent assault was the only charge on Pyatt stemming from his involvement, with the second boy, that night

Renfroe said the boy, who is the son of a policeman, was killed accidentally last September while playing with a pistol.
