SUBJECT: Rande Eugene Grassini

On the 9th of September 1976, Rande Eugene Grassini was arrested by the Washoe County Sheriff's Department. Mr. Grassini was arrested and charged with infamous crimes against nature (oral copulation) and lewdness with a child under 14. His Washoe Sheriff's booking number was #48603.

Mr. Grassini became the Washoe County Sheriff's Department case #I 760244 and information furnished through the County Clerk's office showed him to be the District Court Docket #317419.

On December 23, 1976, Mr. Grassini was sentenced to two terms of six years each, to run con-currently in the Nevada State Penitentiary by District Judge Peter Breen after being convicted of the charges filed against him.

All the above mentioned documents are on file in the office of the Washoe County Sheriff's Department, Reno, Nevada. As the current laws prohibit the law enforcement department from giving out copies of the above mentioned documents to anyone except other law enforcement agencies, I do attest to the existance of these documents.
