

### Sex offendors get 15 years

Two men convicted of sexually abusing children were given lengthy jail sentences by Judge Charles B. Sande in District Court Wednesday morning

Patrick C Calvert, 43, of 1331 Eldorado Drive, and Russell J. Hartwig, 29, of 305 S. 35th St., both were sentenced to 15 years in Montana State Prison at Deer Lodge upon recommendation by County Atty. Harold Hanser.

Calvert pleaded guilty Sept. 14 to sexually assaulting an 11-year-old girl during May and June. Hartwig pleaded guilty Wednesday to sexually assaulting a 9-year-old boy on Aug. 3.

In other District Court action:

Steven C. Small, 24, Ashland, received a Z-year deferred sentence for theft. He was also sentenced to 90 days in county jail.

John S Parr, 27, Parkway Motel, pleaded not guilty to four offenses! He is accused of carrying a concealed weapon one count of misdemeanor possession of drugs, and two counts of felony possession of drugs, all committed on Sept. 30.

Richard W Hoven 18, Laurel pleaded guilty to the Aug 13 theft of a motorcycle. A pre-sentence investigation was ordered.
