26-year-old man charged with child molestation

A 26-year-old west St. Louis county man has been charged with four counts of child molestation for allegedly sexually abusing four boys between the ages of 11 and 15.

John M. Stearns, who told police he is a district manager for the Boys Scouts of America, was charged in warrants issued Thursday by St. Louis County Magistrate Samuel J. Hais. Bond was set at \$50,000.

Stearns was arrested at his home in the 2300 block of Waukon dr., West St. Louis County, by County Police Dets.

Police said several photographs of Stearns and the youths were found during a search of the home.

The investigation began after the mother of one of the youths contacted police, authorities said.

The incidents occurred between April and August at a former residence of Stearns and have no connection with his scouting activities, police said.
