IT IS THEREFORE NOW ORDERED by the Court that the | imposition of sentence upon

the defendant be and the same is hereby suspended for the term of five years from the date hereof, during which time the defendant is committed to the charge and supervision of the Probation Officer of said County of San Diego and of this Court;

IT IS FURTHER ORDERED that said defendant wholly abstain from violating any of the laws of the United States of America, and wholly abstain from violating any of the laws of the State of California, and wholly abstain from violating any of the ordinances of any municipality within this State; that defendant wholly abstain from engaging in criminal or unlawful practices of any kind; that defendant conduct him self in all respects as a reputable and lawabiding citizen; that defendant not depart from the County of San Diego during said term of probation without the consent of the Probation Officer, nor from the State of California without the consent in writing of one of the Judges of the Superior Court of San Diego County;

That said defendant report to the Probation Officer at such times and in such manner as directed and follow such course of conduct as may be prescribed by the Probation Officer; and 1) Register pursuant to 290 PC; 2) Cooperate in a program of psychiatric or psychological counseling as directed by the Probation Officer, at his own expense, and continue in such treatment until released by the doctor or therapist, the probation officer or a judge of the Superior Court of California; 3) Authorize the therapist to submit periodic reports of progress to the Probation Officer whenever requested, at his own expense; (1) Not associate with minor males unless in the company of a responsible adult who has knowledge of this poviction; 5) Cooperate with the Probation Officer and psychiatrist in outlining a treatment plan to be submitted to the Court in an ex-parte report on-or-hefore July 1, 1975; 6)An ex-parte report to be filed with the Court outlining the defendant's progress and performance by October 15, 1975, and that annual ex-parte reports commence April 15, 1976, and each April 15th thereafter, until probation has terminated, outlining the defendant's compilance with and recommended changes in the program; 7) Not participate in any group activities for juveniles either in the capacity of a participant or as a lender; specifically Scout Huster... You are hereby informed that:

Every defendant who has fulfilled the conditions of his probation for the entire period thereof, or who shall have been discharged from probation prior to the termination of the period thereof, shall at any time thereafter be permitted by the Court to withdraw his plea of suity and enter a plea of not guilty, or if he has been convicted after a plea of not guilty, the Court shall set aside the verdict of guilty; and in either case the Court shall thereupon dismiss the accusation or information against such defendant, who shall thereafter be released from all ponalties and disabilities resulting from the offense or crime of which he has been convicted.
