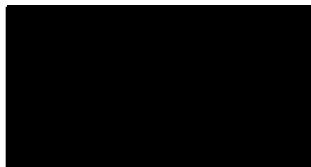

Dear Mr. Ernst:

This is to inform you, in accordance with the recently distributed "Procedures For Maintaining Standards of Leadership", of charges being formed by various parents and the sponsoring institution, Bensenville Moose Lodge, against Scoutmaster Tom M. Burke, 110 W. Butterfield, Elmhurst, Illinois, 60126. Mr. Burke is Scoutmaster of Troop 444 of this council.

The nature of the allegations fall into two categories.

1. Burke cultivated, arranged, and participated in homosexual experiences with selected members of the troop on several occasions.
2. Burke, without the knowledge or approval of the troop committee or sponsor, contracted for goods and services for which there was no money.

This situation was brought to our attention last evening. The council is investigating with the intent of documenting the allegations.

We feel that the allegations are serious enough, should they be documented, to warrant immediate suspension. We will move promptly toward this end once a signed statement is received from one of three complaining parents, in accordance with the above mentioned "Procedures" unless otherwise advised by you.

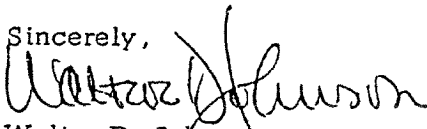
Attached please find signed statements which support allegations made against Tom M. Burke, Scoutmaster of Troop 444 of this council as per my letter of June 17.

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are, therefore, compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that B.S.A. leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the Boy Scouts of America seeks to provide American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you seek to have this decision reviewed, please write to me. I will then see to it that a committee of three Boy Scout volunteers meets with you to consider your case.

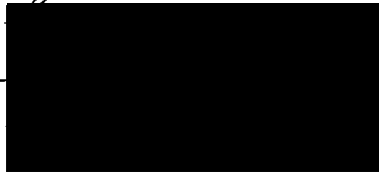
