STATEMENT

1. On the morning of June 10, 1976, I received a call at home from Chuck Scullin, Field Director, stating that Scoutmaster of Troop 251 had called. Mr. informed Mr. Scullin that Anthony Ruggeri had been arrested on a morals charge.

I immediately called Mr. and he told me the following: The Scoutmaster of Troop 251 had called Mr. at 10:30 P.M. on June 9, 1976, and informed him of Mr. Ruggeri's arrest. The Scoutmaster was leaving on vacation and left Mr. to deal with the problem. Mr. Ruggeri was an Assistant Scoutmaster with Troop 251 and had been arrested on either a child molesting or improper moral conduct charge. The charge, Mr. thought, was filed by neighbors of Mr. Ruggeri - parents of a possible new Scout and that the incident occurred with this possible new Scout's brother. Mr. thought it took place within the last week. brother. Mr. also stated that he understood that Mr. Ruggeri had signed a statement but didn't know if it was a confession or just a statement of his side of the story. All the facts were not in so Mr. said he would call me after he knew more.

- called me on the evening of June 11 and stated Mr. Ruggeri would be brought before the Grand Jury on June 16. We decided to wait on any action until after he appeared before the Grand Jury. He is to contact the detective on the case for more details.
- 3. On June 18, Mr. alled and stated Mr. Ruggeri had been indicted by the Grand Jury. He had been given this information by Mr. Ed O'Connell of the States Attorneys office.

- 4. On June 21, I informed Ralph Loen, District Commissioner, of the facts as I knew them in Mr. Ruggeri's case.
- 5. On June 22, I called and arranged to meet him on June 23 to fill out a questionnaire on Mr. Ruggeri.
- 6. On June 23, Mr. Ralph Loen and I met with At this meeting, repeated the earlier information for Mr. Loen and stated there were five complaints against Mr. Ruggeri.
- 7. On June 24, I went to the Clerk of the Court Office and obtained a copy of Grand Jury Indictment #16831 filed June 16, 1976, charging Mr. Ruggeri with five counts of committing a "certain unnatural and perverted sexual practice and five counts of assault."
