

Arrested - November 19, 1976 by Brea Police Department
Charges - Indecent exposure and Child deforment (child annoyance)

12:30 Noon Wednesday, November 17, 1976 - [redacted] arrived home to find Detective Winder from Brea Police Department in his living room interviewing his step daughter [redacted]. This was the first [redacted] and his wife [redacted] knew of the problem. The officer was there in response to information furnished by neighbors.

The story briefly is this:

David Phillips paid [redacted] (approx. 12 years of age) \$1.00 for each day that he could get some girl to come to his house for the purpose of dressing in cowboy boots and bathing suits to pose for him in his livingroom while he sat on the couch with pants and shorts off and masterbated.

The girls were paid \$2.00 each time. There were 3 girls involved; [redacted] age 12 - [redacted] age 11 - [redacted] approx. age 12.

He asked [redacted] to touch the boots (still on her feet) against his penis. He has displays of Playboy nudes on his walls - only of girls wearing BOOTS.

[redacted] was there about 10 times before she quit. [redacted] has gone repeatedly since June. [redacted] entered the picture in September after [redacted] stopped going.

[redacted] father noticed that she had "extra" money and quizzed her about its source. She said that [redacted] had asked her to go to David Phillips house and "dress up for him". The police went to the [redacted] house to verify [redacted] story with [redacted]. He then told the police about [redacted] "posing" for David Phillips. The police quizzed [redacted] and she told them about [redacted]. The police came to quiz [redacted] and this is when [redacted] returned home to find Detective Winder in his living-room talking to [redacted].

All three girls stories were the same. Detective Winder went to talk to David Phillips and David Phillips readily admitted that the girls stories were true.

November 18, 1976 - Creative Winder sent a document for David Phillips' arrest from the D.A.'s office - the charges were indecent exposure and child deformation. Child endangerment.

November 19, 1976 - Dave Phillips was arrested and taken to the Santa Monica Police Department. He pleaded guilty to the charges and was held in jail. He is now free on bail until his arraignment on Friday, November 19, 1976.

UNIT ACTIONS

November 17, 1976 - 7:00 P.M. - [REDACTED] the Unit Committee Chairman, called Ron Corbell, the Unit IR, and informed him of the problem and requested that David Phillips be allowed to go on the next planned outing for November 20, 1976.

November 19, 1976 - [REDACTED] informed George Cowden the District Exploring Executive of the events as she knew them at the time, and he notified his superiors that there was a potential Red Flag developing.

November 20, 1976 - David Phillips did not show for the scheduled meeting.

FOLLOW UP STEPS

1. Jeanne Gaudin will call Ron Corbell to get the latest developments on him. She will request that he write a letter to David Phillips informing him that he is no longer in the Association, which that Post is not responsible. She will deliver a copy of the letter to the council for its files. Ron Corbell will also deliver a copy of the letter together with a copy of the letter and a copy of the letter to [REDACTED].

2. Jeanne Gaudin will get a copy of the medical report for the child's illness.

3. Jeanne Gaudin and George Cowden will check to see what happens at the arraignment on November 19, 1976.
