We certainly feel you are justified in refusing registration in your own council, because of the problems which could be encountered from a relationship standpoint, if the registration were accepted.

It is the feeling that we should have more information that would substantiate our refusing registration in any council to which this man would move. Can you secure for us statements from other individuals, and also some definite statements as to acts which really took place? No where does it actually indicate what happened in the statements which were enclosed. Just what did these homosexual acts consist of?

We shall look forward to securing more information, in order to enable us to keep the case on file.
