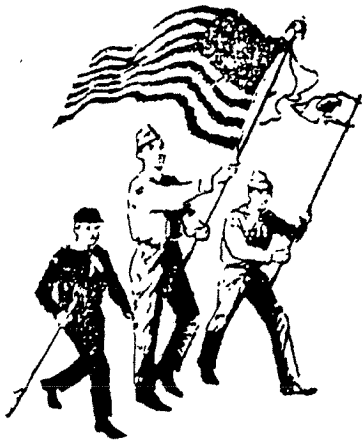

Dear Mr. Hunter:

The purpose of my writing is to advise you of my intent to resign as a District Executive with the Susquehanna Council, Boy Scouts of America. In accordance with my letter of employment, dated June 3, 1975, it is understood that a 30-day written statement will be adequate notice for my termination of contract.

This action is being taken as a result of personal concerns for my inability to effectively cope with the demands of the job. In my year of employment with the Council as a Professional Scouter, I have felt an increasing lack of enthusiasm for a program which has meant so much to me in the past as a volunteer and direct participant as a Scout. I have also neglected my personal life to such an extent that I have developed a loss of touch with myself, my personal ideals, and my goals in life. It is therefore my final realization after many long hours of deliberation that my love for the Scouting program at the present time can best be executed at the non-professional level.

It should be carefully understood that this resignation should in no way reflect any feeling on my behalf of lack of consideration or cooperation shown to me on the part of fellow employees, the Council Executive Board, or volunteer structure. The concern rather rests with my personal resolution that my services to the Council have in many ways been ineffective and would continue to be so.

It is with sincere regret that I terminate this contract with the Susquehanna Council, B.S.A. because of the expense, support, and trust which have been commissioned to me. I am convinced however that as a member of the Professional Staff of the Council that my decision for resignation is for the best of all concerned.

My hopes and prayers continue to be with yours in the realization of the best program available for our youth of today.





DECLARATION OF RELIGIOUS PRINCIPLE

The Boy Scouts of America maintains that no boy can grow into the best kind of citizen without recognizing his obligation to God. In the first part of the Scout Oath or Promise the boy declares, "On my honor I will do my best to do my duty to God and my country and to obey the Scout Law." The recognition of God as the ruling and leading power in the universe and the grateful acknowledgment of His favors and blessings are necessary to the best type of citizenship and are wholesome precepts in the education of the growing boy. No matter what the religious faith of the boy may be, this fundamental need of good citizenship should be kept before him. The Boy Scouts of America therefore recognizes the religious element in the training of the boy, but it is absolutely nonsectarian in its attitude toward that religious training. The following statement is of the events that happened or started my involvement in this matter which is concerning the homosexuality of a professional Tutor Harold Little whom I shall refer to as "Cock" Saturday May 22. Work day (Don't work) Kings Cross/Union. To paper. Subject 343. Order of the court.

Late afternoon Derek Skippie who had called [redacted] and myself aside behind the dining hall and said, "we have a problem. One of our professors also is a homosexual. He told us he had asked one of the Judge officers why he had become inactive lately. The boy told him that "Cock" had wanted to go over the books. I took from the conversation that "Cock" has a trailer home and he is waiting to come to his place. I did not describe in detail what was told me by my only that "Cock" had made advances on Sunday. I also said a couple of other boys had approached him and told him of other homosexual in the school. "What are we going to do about this?" I later on said there was no one to be done. It was decided.

the three of us would confront 'Cork' and perhaps he would resign or apply for a transfer. Some where in the conversation John stated he had asked one of the boys why he had not reported this before and the answer was he thought that Cork did such a good job with scouting and he didn't want to see him get in trouble.

After on the three of us met with [REDACTED] again south of the dining hall. John told [REDACTED] of the problem, which seemed to shake it up as he is now a professional scout. [REDACTED] asked again what we are going to do about it? [REDACTED] said it was now his problem because he was the professional. Again it was stated that Hunter was out of town and would be for 2 weeks. John told [REDACTED] what we were going to do and all decided that our plan of confronting Cork was the thing to do. [REDACTED] and [REDACTED] later looked for me and Cork. We had a meeting in the Trading Post where [REDACTED] confronted Cork. He said again we have a problem and told Cork that he had been accused of being a homosexual by a couple of boys. John said he had found out by accident. He then said in a [REDACTED] that one of the boys had not [REDACTED]

to him. I assumed this boy was from Cork's hometown and that he had gone to a campout with the troop.

Cork first denied this had taken place. He then admitted it had and said he had this problem but thought he now had it under control as he was going with a girl and from the conversation inferred sexual relations between them. He said he couldn't believe that we were confronting him with this accusation instead of turning him in. Some discussion of resigning or transfer then took place. He said he thought of quitting because the job was very demanding. Again the fact that [REDACTED] was out of town and would be for weeks. Cork said he did not want NLE to find out as he had tremendous respect for the man. Cork then said he would resign. In the course of the conversation we told him we thought he had done a good job. He ended the meeting and I returned home.

Since I had several phone conversations with [REDACTED] concerning Cork. These took place the week of May 23. The first telling me that Cork had actually resigned. [REDACTED] call later to inform me Cork had had an accident and I recall him saying Cork's face had been cut. I must tell you that [REDACTED]

John said he had then met with the council
vice president and that he had not talked to

On May 27 Helene Ed Lake called me

Dear Sir,

In a meeting with Harold "Cork" Lieter, [REDACTED] and [REDACTED], the following developments occurred. First [REDACTED] confronted Mr. Lieter with Allegations made by members of Woapeu Sisilija Lodge, Order of the Arrow of Susquehanna Council. The charges consisted of homosexual attempts by Mr. Lieter and in one case actual relations with a boy during a troop outing, at which Mr. Lieter was a guest of a local scout troop. The other attempts made by Mr. Lieter were thwarted by the boys involved.

In the beginning of the meeting Mr. Lieter tried to deny the allegations but when [REDACTED] confronted Mr. Lieter with facts of a given encounter between Mr. Lieter and a young scout, "Cork" admitted his guilt before us.

In closing, Mr. Lieter stated he felt that he had his problem under control now and was not totally homosexual but rather bisexual in nature.

In conclusion we felt that Mr. Lieter should resign in light of the current developments. He agreed. He also stated that he hoped that this information would not be sent on to national. He further stated that he hoped he could continue in the scouting program at another council.

During the evening of May 22nd, 1976, while attending the Order of the Arrow weekend at Camp Karoondinah, I was approached by three adults after the supper meal. The three, [REDACTED] and I left the Dining Hall; at this time I was informed that there was a problem with one of the professionals. They were prepared at this time to come forward with names and facts concerning certain allegations of homosexual activities conducted by Harold Leiter.

Realizing the volatile nature of the allegations, I decided that the fewer number of people knowing the names of those involved the better. Based on this premise, I then asked the three if they would be willing to confront Harold with the allegations. They were, and did so a short while later.

After their meeting with Harold, they again met with me and told me that, having been faced with the accusations, Harold had admitted, with some relief, their validity. I asked if there was any doubt whether they could keep things under control until after the weekend activities were over. There being none, I departed camp.

Sunday, May 23rd, 1976, I called Harold on the telephone, and I told him that he should see me in the Williamsport office on Monday. At this time I told Harold that, as far as I was concerned, he had only one choice even though the volunteers had offered him two choices (transfer or resignation). I did not specify the choices, and Harold's answer was that he agreed he had only one choice and would hand in his resignation. Harold then asked what he should do until termination and my answer was to divorce himself from any and all activities pertaining to his role as a Professional Scouter.

On May 24th, while preparing to go to the office, I was called by Harold, who then came out to the house. We discussed the matter while I had breakfast, and again the subject was the maintenance of a low profile on the entire matter so as to preclude involving more people than need be. It was on our way to the office that Harold was involved in an automobile accident which required emergency treatment.

After Harold's return from the hospital, his resignation was formally tendered pending approval by Mel Hunter, who was at that time on vacation. Jerry Olsen being in charge at the time, put Harold on sick leave. Jerry was informed only of the resignation, not of the reason for the resignation. It was then I was told that nothing could be done on the

resignation until Mel Hunter returned from vacation. I was not pleased by the aspect of a two week wait, but at that time saw no other solution which would keep the problem from mushrooming.

Wednesday evening, in conversation, [REDACTED] said that he would inform [REDACTED] to assist in terminating Harold's contract immediately.

Thursday, May 27, 1976, I spoke with [REDACTED] regarding [REDACTED] and was informed that he was with his parents and was unavailable. I still felt that this whole business should have been able to have been accomplished a lot faster. Thursday evening I was called by [REDACTED] who informed me that one of the boys, [REDACTED] was receiving obscene phone calls. At this juncture, I told [REDACTED] I was pulling the plug on the problem and would take immediate action. ✓

Friday, May 28, 1976, I arrived at the office and informed [REDACTED] of the problem and the steps I had taken along with subsequent events. He then took the steps necessary to inform the appropriate people. [REDACTED] was contacted, and a list of all parties involved with Harold or privy to the information about Harold was compiled. Friday afternoon, [REDACTED] and I met with [REDACTED] and explained to him what the problem was and what actions were taken.

My action in the above was prompted solely by my motives to prevent unnecessary hardships or publicity for the individuals involved and any adverse reaction toward the Council or the Boy Scouts of America.
