
Thank you for your letter of May 19, and the attached copy of the newspaper clipping concerning George Childs. We have placed this information in our file.



The enclosed information on Mr. George "Corky" Childs is a fact and on record at the Meade County States Attorneys office in Sturgis, SD.

Mr. Childs has; according to the Pennington County Deputy Sheriff Garry Buffington; submitted to a polygraph test and confessed to an unnatural relationship with at least two boys.

Mr. Childs was suspended as Scoutmaster of troop #56 in Rapid City on Wednesday, May 12th. Mr. Childs is white, age 47, scars on face, hands, and arms from a severe burn. He is single and has worked as a custodian for the Rapid City Public Schools for the past four years.

Mr. Childs is presently in custody in the Meade County jail and will stand trial.
