
Dear Mr. Erlinger:

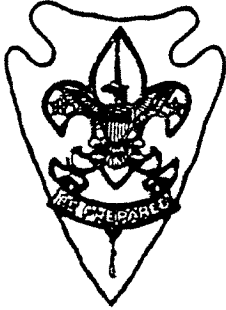
