STATEMENT

MR CLAUDE MACEMORE WHO DID LIVE AT 245 HILLCREST DRIVE, ELKIN, N.C. 28621 AND WAS A MEMBER OF THE OLD HICKORY COUNCIL HAS BEEN FOUND TO BE A HOMOSEXUAL. HE WAS SCOUTHASTER OF TROOP 658 AND LATER WORKED WITH TROOP 686. HE HOUED FROM THIS AREA TO COLUMBIA S.C. ABOUT SIX MONTHS AGO HE RETURNED TO THIS AREA FOR ONE WEEK THIS SUMMER TO TAKE TROOP 686 TO SUMMER CAMP. ON TUESDAY JULY 3 1974 WHILE HE WAS AT CAMP RAVEN KNOB TWO STAFF MEMBERS INFORMED ME OF MR MACEMORES PRIOR INVOLVMENT WITH YOUNG BOYS PRIOR TO '115 DEPARTURE ABOUT SIX MINTH AGO, I CONTACTED THE SCOUTHASTE TLEL AND HAD HIM REPORT TO CAMP. WE THEN CONFRINTED MR MACEMORE WITH THE ACCUSATION. AT FIRST HE DENIED THE CHARE AND WANTED TO KNOW WHO HADE THEN. I INFORMED HE MACEMORE THAT IF IT WAS TRUE I WOULD PREFERE NOT TO INVOLUE THE BOYS BUT IF IT WAS FAUSE WE WOULD GET ALL CONCERNED TOGATHER AND SEE WHO WAS TELLING THE TRUTH. AFTER THINKING IT OVER MR MACEHORE SAID IT WOULD BE BEST FOR ALL IF HE JUST DEPARTED. THERE IS NO EULOFICE TO INDICATE THAT THE BOYS HAD ANY THING TO GAIN BY INFORMING ME OF MR MACEMORE AND WHILE THE MACEMORE NEVER CAME OUT AND SAID THAT HE WAS A HONOSEXUAL HIS ACTIONS STRONGLY INDICATE THAT HE IS.
