Dear Paul:

Pursuant to your request of August 23, 1974, we have been in contact with Scoutmaster [REDACTED] of Troop 330, Weiser, Idaho. Scoutmaster [REDACTED] position in this matter has not changed in the last few months; that is, he insists the boy's parents not be informed of this incident apparently for the boy's own good.

When we suggested the boy might make a written statement or sign a prepared statement, we were given a flat refusal by the Scoutmaster. We were informed that the boy had dropped out of the Troop completely since summer camp and has only returned to the last two Scout meetings held during the month of October. It is the feeling of the Scoutmaster that this request for information should be dropped for the good of the boy. Because we feel the Scoutmaster is much closer to the home situation, we will not press him or the boy for any further statements or information.

We are sorry we could not obtain the information you requested. It is unfortunate that many of our 1974 Camp Staff members know something about the incident involving Mr. Krigbaum in camp. This knowledge has led to some rumors amongst volunteer Scouters here in the District. We in the Council will not confirm or deny any of the rumors brought to our attention. We will however, continue to keep a close surveillance on Arthur N. Krigbaum's Scouting activities and notify



This letter is to transmit to you the original information given to us by our camp director and a scoutmaster concerning one Arthur N. Krigbawn.


The signed statement is self explanatory and John Warnick (SE) and myself believe action should be taken in light of the facts it presents.

Mr. Krigbaum is a very slow individual - that is he has never really matured; this we have noted through personal observation. He is quite active with a local scout troop, registered as an assistant scoutmaster (6-106-5-49), expiration date of 1/31/75). The scoutmaster of the troop informed me that Mr. Krigbaum is an assistant in "name only" - that he lacks leadership ability and has never been allowed to take the troop out alone.

Mr. Krigbaum is also quite active with our Order of The Arrow and this of course presents a problem.

Please consider the enclosed statement and advise us as soon as possible.

To whom it may concern:

This evening, a minor of Troop 330, of Weiser, Idaho, reported to us, a homosexual act performed on him by an adult, Mr. Art Krigbaum, last evening at Troop 330's campsite in Camp Tapawingo.

Mr. Krigbaum had arrived in Camp Tapawingo on Friday, August 2, 1974, to stay with the troop he is registered with, Troop 49 of Boise, Idaho. He stayed overnight Friday, and all day Saturday.

This morning, Sunday, August 4, 1974, it was brought to the attention of [REDACTED] the Camp Director, that Mr. Krigbaum had stayed overnight, not leaving with his troop on Saturday. He was assisting the Commissioners with camp check-in, and was invited to stay with the Eskow's in their cabin. He did leave some of his personal gear in the cabin, but decided to stay the night in his car. It was discovered that he spent the evening from approximately 10:00 P.M. until about 1:00 A.M. in Troop 330's campsite, and in the tent of one of the Scouts, allegedly telling homosexually suggestive stories. Because of this, Mr. Krigbaum was asked to leave camp by 3:00 P.M., Sunday, which he did without question.

Later, on Sunday evening, it was brought to the attention of [REDACTED] that more than just story telling had gone on.

After campfire this evening, the Scout involved in the act was interviewed by [REDACTED] the Scoutmaster of Troop 330 and [REDACTED] the Camp Director.

The Scout involved told us that Mr. Krigbaum wanted to talk to the Scouts of Troop 330, and this Scout mentioned that his back was sore. Mr. Krigbaum then told him that he would give him a massage, which he proceeded to do. As Mr. Krigbaum proceeded giving the massage, his hands went lower, until he was "playing with the Scouts 'personals'". The Scout asked him to stop several times, and tried to move Mr. Krigbaum's hand. However, Mr. Krigbaum would not stop, nor would he move his hand when the Scout tried to move it. This continued until about 1:00 A.M.
