On January 9, 1978 In the County Court, Branch #3, in the City of Beloit, Rock County, Wisconsin, the defendant was found quilty of having sexual contact with a person 12 years of age or younger, in violation of Section 940.225(1)(d) of the Wisconsin Statutes and upon conviction the court did order as follows:

"You are committed to the State Department of Health and Social Services for a period not to exceed sixty (60) days for a presentence social, physical and mental examination under the provisions of Section 975.01, Wisconsin Statutes."

IT IS ORDERED that the Sheriff of this County take the defendant into custody and that the Court forthwith issue five certificates of commitment and deliver two to the Sheriff; that the Sheriff convey the defendant to the Central State Hospital. Waupun, and into the custody of the superintendent; unon completion of examination the superintendent shall notify the Sheriff of this county and and at that time, but no plater than Sixty (60) days from this date, the Sheriff shall take the defendant into custody at the gates of the hospital and shall return him to the common lail of this county. That thereupon the Sheriff shall notify

this Court and the Judge of this Court of this fact and shall hold the defendant until further order of this Court.

IT IS FURTHER ORDERED that upon notice from the Sheriff that the defendant is in his custody the Judge shall immediately notify the attorney of record of this action.

IT IS FURTHER ORDERED that the pertinent data in respect to this case which is in the possession of this court and of all public officials be made available to said Department upon its request.

IT IS FURTHER ORDERED that the Department mail an original and three (3) copies of the results of this examination and its recommendations to THE HON. EDWIN C. DANIBERG, JUDGE OF THIS COURT. Dated this 9th day of January, 1978.
