We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me. explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.

At nighttime as they were getting ready for bed ______ was in a playful mood and was shoving and grabbing, etc. This progressed to one point where _____ put his hand inside _____ sleeping bag. relates at this point he was beginning to get worried, scared and to realize that something was wrong, and that he yelled in a loud voice "stop it, you faggot". The Scoutmaster, then exposed himself to _____ Although no further incidents happened that night, the next night _____ was not invited to share the tent again with

indicated that on numerous occasions had been very reckless in driving while boys where in the truck, in speeds of 90 to 100 miles per hour on the freeway. stated that gets along well with the younger boys, but the boys over 12 hate him.

related an incident involving the troop when 10 Scouts in truck drove to a Merit Badge Day held at Three of the boys, Three of the boys, All three were standing by the truck as prepared to leave and were told that he was not happy with their performance at the Merit Badge Day, and drove off without them. Was forced to call his Dad so that they could provide transportation back to their homes.

indicated that it was widespread knowledge among the older boys in the troop that $\bar{}$ — made advances to several of the boys. His pattern was always to invite the boy to share his tent with him.

told of another incident related to him by one of the Scouts on a trip, that he, had not attended. Five of the best Scouts in the troop selected by Lin, were invited on a trip to Wyoming, Las Vegas and Canada. It was a two-week trip. ..., a Scout in the troop, woke up one night to find the troop, bag.

He talked about another troop state-wide trip to Las Vegas, where pulled a camper behind his truck, and three of the boys were locked out of their camper untkl 3 a.m. in the morning because had gone into town and left the boys by themselves.

stated it was common knowledge among the older boys and the Scouts that there has been several advances made on camping trips. In one case a boy was invited to go to a movie with .

Following our interview with and Fra.... and I discussed the matter and decided that our procedure should be to submit a letter signed by the Scout Executive requesting that not continue his registered leadership status with the Boy Scouts of America. We agreed that we would deliver this letter asking in leading a join us at the first available date. I indicated to that our recommended procedures suggest that such a letter should be hand delivered but that no accusations should be made whatsoever.




