On the afternoon of February 16, 1990, I received a telephone call from an individual by the name of Gary E. Busher. Mr. Busher lives in California and was placed on the file in 1966.

Mr. Busher asked many questions related to being reinstated in Scouting and removed from our file. He, apparently had talked to the Scout Executive and was aware of the file and, also, was told by the Scout Executive that he could get reinstated, if he sent a letter indicating that the charges had been dropped.

I explained to Mr. Busher he would have to go through a review procedure which would take place in the Western Region. I suggest he write to Mr. Richard Harrington the Regional Director, and explain his side of the situation sending any supporting documents which he had.

Mr. Busher indicated he is a school tracter in a special private school and has been for quite some time. I suggested he include anything he felt would be helpful to his stand with his request for a review of the matter. I did not give him any encouragement, but told him in some cases individuals were allowed to register after many years have passed depending on what the original charges were.

I do not know what follow up may occur but I felt this memo should be in our files for future use.

We are herewith enclosing a credit notice of \$1.25. Kindly delete Mr. Busher's name from your records.





Gary has been a Scout and assistant Scoutmaster of Troop 99, Riverside, from December 1964 to December 1965. He is a son of Edison (Ed) Busher, owner of a motel at Idylliwld; past presider of the Idyllwild Rotary Club, former Scoutmaster, Commissioner, and Eagle Scout, etc.

Gary Busher signed up for a Scout leader training course at Idyllwild which was attended by 2 deputy sheriffs, who reported his background to us, resulting in our discovery of a criminal record.

Gary was arrensted February 25, 1961, by the Riverside police department for 288 PC perversion and sentenced to Patton State Hospital. He was on probation for three years. At the time he was a student at Riverside City College. He was born March 22, 1941, is 6' tall, 183 pounds, brown hair, blue eyes. He has a FBE Titler Because of this record, he must register with the police department upon his arrival in any community.

He is not registered in our Council and we do not intend to register him. I think he should not serve in any other council.
