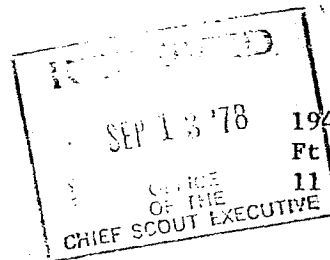

Sir:

During the time period 1963 to 1975, I was intermittently registered as a Scouter, and earned a 10-year veterans pin. In 1975, when I tried to register with the Lake Bonneville (Utah) Council (I was serving as head of the Scout-o-rama for the Box Elder-Birdhaven District) I was denied registration. No reason for the action was ever given, and to-date I still do not know why.

In 1975 when I was assigned to Hawaii, I was tasked by my Church to serve as director of the APYW program, which necessitated me registering as a Scouter. However, since I could not be registered, I had to be relieved of the position. Since that time, I have been unable to accept any Church position which in any way entailed registration with the BSA.

I would like to know, under provisions of the Privacy Act, why I am not being permitted to register, and what (if any) actions I can take to correct the situation. I have three sons of my own coming along now who will soon be involved in Scouting. I dread the thought of not being able to participate in their Scouting years, especially after all the time I have put in for others in the past.

I expect to hear from you in the near future, and appreciate your concern.

SUBJECT: RALPH L. COLEMAN

1. Ralph L. Coleman has been registered as Scoutmaster of Troop 193, sponsored by the Fraternal Order of Police Chapter 93, Urbana, Ohio. This unit is in District 2 (Wyandot) of the Tecumseh Council.
2. Coleman has been employed in the past as a teacher and for the past 16 months has been a member of the Urbana, Ohio Police Department where he was employed as a police dispatcher.
3. Coleman is a male caucasian, 6' 1" tall, weighing 170 pounds. He has brown hair and green eyes. His Date of Birth is 23 February, 1945.
4. On 1 September 1970 Coleman was arrested by the Urbana Police on a charge of assault against a minor. The basic facts are outlined in the attached affidavit and warrant to arrest.
5. Additional documentation is not available at this time. However, the two juveniles that were involved (only one is named in the complaint) were taken to the Ohio Bureau of Criminal Investigation at London, Ohio, where they were given Polygraph tests. The results of the polygraph basically substantiate the truth of the allegation in the affidavit.
6. Coleman will have a preliminary hearing in Municipal Court later this month at which time he will be bound over to the Grand Jury which begins its new term in January 1971. If the Grand Jury returns an indictment against him, Coleman will stand trial in Court of Common Pleas. Section 2903.01 of the Ohio Revised Code, under which he has been charged, makes this offense a felony.
