Dear Howard:

It is with the greatest reluctance that them forwarding the name of William R. Cormana to be placed on the confidential file.

A former short-time professional man and a Scoutmaster for some years since that time, Bill was charged with "indepent liberties" involving specifically one Scout in his Troop. He readily admitted the charge and the authorities have agreed not to prosecute on two conditions:

- 1. That he leave Scouting immediately. Of course I assured them of this and well with the authorities and Bill to clinch this that he well knew as a former professional anyway.
- 2. That he place himself in the hands of a competent psychiatrist and take whatever treatment is indicated, the Sheriff to be notified by letter by the doctor certifying this.

Knowing that the law was working on the case last week, we stood by until the legal aspect had all been unwound and then, at the request of the Sheriff, stepped into it. Not only were the officers interested in trying to help Bill but the were extremely anxious that Scouting not be hurt in the manner in which they handled the case.

The background on Fill is as follows:

Age - 40. Height 5'10" Weight 170 lbs. Color Hair - Brown mixed with gray

Color Eyes - Blue

Scoutmaster, Troop 210, Inland Empire Council - Lifelong resident of immediate area. Former District Executive Idaho Panhandle Council for about 1-1/2 years living in Sandpoint, Idaho.
